MedSafe is an ultimate-user unused medication disposal system. This easy-to-operate system accepts controlled (Schedules II-V), non-controlled, and over-the-counter medicines. MedSafe is intended for use in long-term care facilities, law enforcement, narcotic treatment programs, retail pharmacies, and hospitals and clinics with on-site pharmacies. Since the release of the updated DEA disposal regulations in 2014, hundreds of these facilities have installed MedSafe collection receptacles.

MedSafe prevents pharmaceuticals from circulating into community water supplies due to improper disposal. It can also reduce the chance of unintended and illegal use of drugs by providing a safe and convenient disposal option.

## Collection Receptacle Features

- 14-gauge powder-coated steel
- Secure fastening to a permanent structure (floor or wall)
- One-way medicine drop with locking door that prevents overfill
- Double-locked front door access

## Inner Liner Features

- Include prepaid return via common carrier
- Unique identification number enables tracking
- Waterproof, tamper-resistant, and tear-resistant
- Sealable immediately upon removal from the collection receptacle without emptying or touching its contents
- Internal contents are not viewable from the outside when sealed
